## **Rules**

The awards program is open to Chicagoland AGC contractor members for projects completed between October 1, 2019 and September 30, 2020 located in the Chicagoland area. A company may only enter the same project once.

A company may submit up to two projects per category. In a joint venture submittal, the controlling partner must be a Chicagoland AGC member in good standing. Non-members will not be recognized.

A minimum of three projects from three different companies must be entered in a category before awards will be given in that category.

Members can enter projects in one of four award categories, and the Opening Eyes to Construction category.

# **Entry Categories**

#### **New Construction**

Traditional building projects such as office buildings, hospitals, schools, libraries, museums, multi-family housing, etc.

#### Renovation

Includes restoration or renovation of nonhistorical, existing buildings with more than 50% square footage having been restored/renovated.

#### **Specialty Construction**

Performed specialty work, i.e. mechanical commercial, mechanical industrial, electrical commercial, electrical industrial, exteriors, interiors, landscape/hardscape/sitework, other commercial or industrial specialty construction, etc.

#### **Opening Eyes to Construction Award**

The fact that the industry is experiencing a labor shortage is not news to our members. What is your company doing to address this need? Please describe how your company promoted construction to students and those looking to change careers. Examples of qualifying actions: fostering a mentorship program, hiring interns, attending career fairs, etc.

## **Project Story**

Submit a written explanation about how the project addresses each criterion. The complete written portion should be on an 8.5x11 paper; minimum 1.5 spaced and should not exceed three pages. Up to eight phots may be used to help illustrate the text. The project story is the primary tool used to determine the winning projects.

## **Photographs**

Please include five to ten electronic color photos of the project. (These photos are in addition to those on the display board, but duplicates of photos on the board may be used.) The photos should be saved on a flash drive as high-resolution picture file, such as .jpg. Photos will be used for the video shown at Constructors Connect and media purposes.

## **Display Board**

A visual description of your project should include photos of the project, the name of your company and the project description of the key aspects of the project.

Securely fasten elements to the front of the board. Displays should not exceed 35x45 inches, can be hinged or unhinged, and must weigh less than 10 lbs. CAGC will employ the utmost care when handling the display board but assumes no responsibility for any damage.

## **Company Logo**

Please include a high-resolution file of your current company logo in .jpg or .png format.

The contractor's toughest critic, a jury of peers, will choose winning projects. A subcommittee of Education & Training Foundation Board members will review the projects and determine one winner for each category. Winners will be selected based on the general criteria listed on page one of this document. Small and large projects are considered equally. All decisions made by the panel of judges are final. Sophistication of the presentation is not part of the selection process, but completeness in addressing how a project meets the criteria is essential.
